KNOW ALL MEN BY PRESENTS, that \_\_\_\_\_ as principal, and \_\_\_\_\_ and \_\_\_\_\_ as survey of sureties, are held and firmly bound unto the City of Farmersville, in the penal sum of ONE THOUSAND DOLLARS (\$1000), for the payment of which well and truly to be made, we jointly and severally bind ourselves, our heirs, executors, and administrators, personal representatives, successors and assigns, firmly by these presents.

The condition of this obligation is such that, whereas the above bounden principal has this day made application for permit to conduct business as an Itinerant vendor in the City of Farmersville, for a period of 15 days ending \_\_\_\_\_, 20\_\_\_\_, and for additional renewal periods as granted.

NOW, THEREFORE, in consideration of said permit being issued to principal, the said principal shall:

1. Indemnify and save harmless the City of Farmersville, its officials and employees, and their successors from and on account of any and all judgments, claims, demands, losses, costs, expenses, or liabilities of any kind whatsoever which said City of any or all of the persons above enumerated may sustain or which may be recovered from it or them, from or by reason of the insurance of such permit or by reason of any act, neglect, or thing done under or by virtue of the authority given in such permit;
2. In all respects be bound hereby to any and all applicable requirements and provisions required to be in bond by existing and hereafter existing ordinances, rules, and regulations of the City of Farmersville and the other laws, the same as though such requirements and provisions were fully set forth in this bond, and by reference such requirements and provisions are made part hereof;
3. Comply with and faithfully observe and obey all applicable rules and regulations and ordinances of the City of Farmersville now or hereafter existing and all other applicable laws now or hereafter existing affecting or relating to itinerant vendors;
4. Pay any penalties that may be imposed during and for the period of said permit;
5. Pay all damages occasioned to any person or persons by reason of any wrongful, fraudulent, or illegal conduct while conducting business activities in the city by principal or the principal's agents or employees.

Compliance with all and several of the above enumerated items shall make this bond void; otherwise it shall remain in full force and effect for the duration of this permit, renewals thereof and for two years thereafter.
