III. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

A. Set definition of Committee Scope.

Kevin presents two examples of the ordinance documents. Advises one has been vetted through P7Z and city attorney the other is just an example of a more condensed version. Jim Foy speaks on how the committee would look at the two examples. Make a recommendation to P&Z and the committee would disband. Paul Kelly asks if the committee would also take up residential homes. Consensus from committee was to seek more clear guidance from P&Z on the scope and overlay area.

 Discussions to possibly expand the overlay and modify the restrictions inside the district. Jim Foy wants to speak
 to other cities first but wants to delay until further discussions can be help on the topic. Wants to read up on the
 documents before action is taken.
